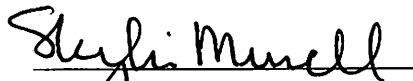
Consent Items:

1. Update from Murchison Events Committee- July 4th show and expenditures
 - a. 4th of July event went good- it did rain so was delayed over an hour. \$325 was additionally spent on fireworks for a total of 5 from the events committee. Back to school bash is set and working on getting everything for the event Saturday. Invoice for Kellys Rental discussed. Kayla is requesting more funds as was a misunderstanding with the school supplies being donated and so \$1200 was spent between events committee and the Fire Department to get the supplies needed. Fire department also paid for about 350 burgers, but we might need more so she is requesting an additional \$1000.00 to offset the expenses. Bradley Gray states there's funds in the advertising & promotions, there should be enough there to budget it. Er haven't rolled the funds over that weren't used unless needed.
 - i. Wade Carter motions to approve \$1000.00 under Advertising line to cover funds, Bobbette Bandy seconds, passes unanimously.
