Consent Items:

1. Approve Council Meeting October 14, 2025 Minutes and October 2025 Financials
 - a. Danny Garza motions to accept October 14, 2025 Minutes and October financials, Torance McClean seconds and passes unanimously.

Mayors Report:

1. Update on clean up day- October 24-26th 2025 happened
 - a. No issues with the clean up, everything went smoothly.
2. Update on Grant for Comprehensive Plan and Grant for infrastructure upgrades from Skylier
 - a. Updates on both Grants given, Working with Carlos and Laruen from GrantWorks on both. Once we get information back to survey after November 18, 2025 and send it back to GrantWorks, they will tell us the next steps for the Grants.

Water Report by Jeremy Crocker: Jeremy Crocker goes over work done for the month which consisted of 2 sewer lines by School were hit by utility company but was fixed. Wildflower had a leak and was fixed, meter tap on the Hwy was completed, went over invoices that were received for parts from Underground. Jet Machine needs some work as the hoses are bad, tanks leaking, Jeremy will get us Quotes on parts. Will get a invoice together for Brownsboro for using it.

1. Status of meter installs
 - a. 60 Meters were installed, training is set for November 18 and 19, 2025.
2. Update on all TCEQ related matters
 - a. Bradley Gray had letter from TCEQ shows enforcement from 2024 was resolved.
3. Update on jetting line by the bank
 - a. Once manhole was jetted no issues

New Business:

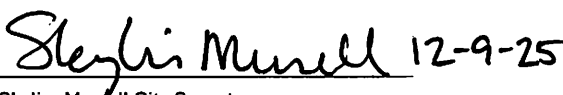
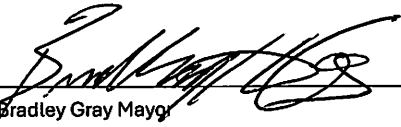

 - a. Danny Garza motions to remove Jeremy Smith and Gayle Furlong from all bank accounts and finances, add Torance McClean and Boyd Sauter to all bank accounts and financials, Bobette Bandy seconds this and passes unanimously.

2. Inquire as to any interest from the council about checking to see if we can contract with Sheriff's office for animal control and/or patrols exclusive to Murchison.
 - a. The city wont make money on it, it will cost us money, We have no ordinance, we would need to see if the Sheriffs office would contract with us or a shelter if we are interested in using them.
 - i. Torance McClean motions to get more information on the animal control part, drop patrol, Boyd Sauter seconds this and passes unanimously.
3. Penny issue with the Government ending production.
 - a. Torance McClean motions to accept to round up if paid in cash and difference will be credit on next bill, Boyd Sauter seconds this and passes unanimously.

Old Business:

1. Revisit filtration system at Water plant tabled last month, take any action if necessary.
 - a. Jeremy Crocker made calls to some people but waiting to hear back from them.
2. Revisit water well repair at ballfield, take any action if necessary.
 - a. Quote discussed to re pipe, cutting the bolts to replace them.
 - i. Danny Garza motions to approved repair of well 2 with the \$2000.00 quote given, Torance McClean 2nds this and passes unanimously.
