- 1. Discuss welcome signs and welcome/holiday banners

Old Business:

- 1. Ballfield renovation started
 - a. Renovations started this week, bid process was done second week of March. Fence, dugout and bleachers are being worked on currently. \$14,500 for Phase I, Phase II bids went out April 2, 2024; deadline to be turned in is April 26, 2024
- 2. Update on Business Improvement Grants

- a. The grants we awarded to Smith & Sons six month start date was March 6, 2024, on March 28, 2024 Q Wilcox hand delivered a letter to Smith & Sons about why they haven't started yet. A response was received that day stating on start date due weather and fiber optic crews. Bee Line's deadline is April 6, 2024. Waiting on somethings to be delivered still.
 - i. Cornelia Haynes asked what if they don't use all the grant funds?
 - ii. The money is given back to the EDC, receipts of projects will be required.
