### **CITY OF MURCHISON TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM**

In accordance with Texas Administrative Code, Title 4, Part 1, Section 30.7 City of Murchison will hold a public hearing at 6pm on January 12 th , 2026, at 9540 FM 773, Murchison, TX 75778 regarding the submission of an application to the Texas Department of Agriculture for one or more Texas Community Development Block Grant Program (TxCDBG) grants for Program Years 2025-2026. City of Murchison may be eligible to participate in the Community Development Fund, the Colonia Fund Construction Program, and/or the Downtown Revitalization Program. The purpose of this meeting is to allow citizens an opportunity to discuss the citizen participation plan, the development of local housing and community development needs, the amount of TxCDBG funding available, all eligible TxCDBG activities, and the use of past TxCDBG funds. The City encourages citizens to participate in the development of TxCDBG application(s) and to make their views known at this public hearing. **De acuerdo con el Código Administrativo de Texas, Título 4, Parte 1, Sección 30.7, la Ciudad de Murchison llevará a cabo una audiencia pública a las 6pm on 1/12/2026, en 9540 FM 773, Murchison, TX 75778 con respecto a la presentación de una solicitud al Departamento de Agricultura de Texas para una o más subvenciones del Programa de Subvenciones en Bloque para el Desarrollo Comunitario de Texas (TxCDBG) para el Año Programático 2025-2026. La Ciudad de Murchison podría ser elegible para participar en el Fondo de Desarrollo Comunitario, el Programa de Construcción del Fondo para Colonias y/o el Programa de Revitalización del Centro Urbano. Shawna McElfish is assisting us through Grant Works on the CDBG – Funded by HUD and then dispersed to the counties. Infrastructure, water and sewer work can be used for the Grant if it meets the requirements. No public housing is listed here, no social services other than the Food Bank through the church. Phase one was started with Q Wilcox the old city secretary and he listed things like sewer/water, waste plant help, reconstruction of streets, hazardous properties needing cleaned up and should we need to add anything else. Grant is for up to \$750,000.00 for the city paying in \$15,000.00. Areas for the grant have to be in low income areas, Engineer can help with that and Grant works with any surveys or questions for the citizens. Grant Works will make sure that the City has picked and Engineer for the job, will inspect with the contractor for work to be done.

Interest for Projects- water lines North of the train tracks, sewer lines and certain streets. Kickoff Project Meeting is next and Skylier will be emailed on this information and when to attend.

Danny Garza motions to adjourn meeting, Boyd Sauter seconds this and passes unanimously and meeting is over at 6:29pm.
