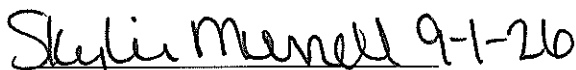
Old Business:

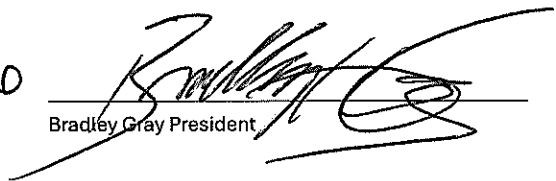
1. Discuss and possibly take action on city mural at water tank.
 - a. Jarrod Boggess showed up to speak about doing the mural the EDC approved with a budget of \$4500. He didn't have anything showing his work he has done but said he has done paintings for businesses in Canton. He will send Skylier references and proof of some of his work and what ideas he might have for the water tank.
2. Discuss about Rooted grant being presented to City Council next Tuesday.
 - a. Grant of \$20,000 was approved for Rooted for improvements to be made. DJ Warren was not here but was not needing to attend, Public Notice will be requested in the paper, 60 days from that day to allow public to petition. Public hearing will be held, allow 60-day timeframe and after 61st day then half of the funds can be presented to the business.

New Business:

1. Discussion about 2027 EDC Budget, work will begin on it in October.
 - a. Budget should be similar to this year for 2027 budget. Think of any projects that might be feasible for the budget or business grant opportunities.
